An Unsustainable Path!!

- As the debate about what causes climate change rages on, one fact is clear—weather is becoming more severe and unpredictable
- Helena—Record intensification—2 days--wave to cat 4--record rainfall
- In 2023, the "resilience gap" was \$124B—by 2030, projected to be \$240B
- In California, drought/Fires and Floods occurring simultaneously!
- Site location consultants now consider and disaster risk reduction:
 - "If we are looking at a region that has been subject to disaster loss, our clients will require that they prove steps have been taken to reduce disaster risk"—Mark Sweeney, leading site location consultant whose clients include Boeing, Nissan, Airbus, and others
- It is also critical in order to retain and grow existing industry
- Attracting professionals and innovative talent—also an issue


Helene Impacted 7 States--Massive Flooding



What <u>IS</u> Economic Resilience?

- Economic Resilience is the ability of a community's businesses and economic development efforts to better withstand, and recover more quickly from, adverse incidents of any kind
 - Incidents include natural and manmade disasters, pandemics, economic upheavals, civil unrest, acts of terror, armed conflict, and cyber attacks
 - Resilience includes response, recovery, & risk mitigation







Economic Resilience Components

- 1. Organize: Convene a Disaster Resilience Task Force
- 2. Assess: Perform a comprehensive resilience assessment
- 3. Identify: Based on assessment, identify shortcomings
- 4. Gain Knowledge: Direct and Indirect Research, Advice
- 5. Secure Resources: Funding, Expertise, Assistance
- 6. Take Action: Create a step-by-step action agenda

Actualizing—Real Examples—Resilient Recovery

New Orleans—Katrina—Dutch Dialogues, First of 100
Resilient Cities to Adopt a Resilience Strategies, Flood
Protection System: Cost \$17 billion, estimated savings \$60
Billion (Difference in estimated damage-Katrina and Ada)

- Joplin, MO—Tornado—Emergency fund, "back in business"
- Eastern OK County—Resilient Business Network—Mutual Aid
- Yuba-Sutter EDC—CEDS Resilience/Recovery—8 Initiatives

Puerto Rico-"Transformative Recovery"

- After Irma and Maria devastated the economy, EDA-led Economic Recovery Support Function--unprecedented recovery, building economic and resilience capacity in forprofit, nonprofit, and public sectors, plus Blue Economy effort
- Established the first-ever EDD in Puerto Rico
- Air cargo exemption, airport resilience, pharma logistics
- Intensive training and matching for NGOs and municipalities, presented to public/private funders
- Along the way, had an incident to "practice what I preach"

- Bipartisan infrastructure Bill--\$47 billion for infrastructure resilience

- New areas of funding interest: Agriculture (Gates), Risk Analysis/Climate Modeling (UNDRR), Migration (IOM), Coastal (NOAA), Insurance (InnSure), Infrastructure (UNECE), Climate Finance (WAPPP)
- Initiatives/Federal \$: CDRZ (FEMA), CDBG-DR (HUD) HMGP (FEMA), SBA
