


#### **Program Summary**

- In September 2022, USDA announced \$400 million to fund the USDA Regional Food Business Center initiative.
- In May 2023, 12 organizations were selected to lead efforts in their region and serve all areas of the country.
- The USDA Regional Food Business Centers support producers by providing technical assistance and capacity building to farms and food businesses to increase their viability and access a variety of local and regional markets.
- By strengthening connections between rural and urban areas, the Regional Food Business Centers drive
  economic opportunities across the regions, creating a more diversified and resilient food system.
- The USDA Regional Food Business Centers serve small and mid-sized food and farm businesses and prioritize work in historically underinvested communities in their region.

#### RFBC Roles



**Coordination** - Act as regional hubs coordinating across geographic areas, with USDA, other federal, state, and tribal agencies with relevant resources, regional commissions, and the other Regional Food Centers. They also conduct outreach to underinvested communities and businesses.



**Technical Assistance** - Provide direct business technical assistance to small- and mid-sized food and farm businesses (producers, processors, distributors, and other businesses within the food supply chain) and food value and supply chain coordination.



**Capacity Building** - Provide financial assistance through business builder subawards up to \$100,000 to support projects focused on emerging regional needs and businesses that are working towards expansion and other investment.


#### North Central RFBC

- 2. Helping direct culturally specific strategies and outcomes from expertise through Native CDFI's, Latino Economic Development professionals and small/mid-sized food value chain businesses
- 3. Learning how grassroot partners can efficiently transform an industry on a multi-state level that creates long-term system impacts



#### **Technical Assistance Services**

- Regional food business technical assistance providers offer direct technical assistance to small and mid-sized food and farm businesses, including grant writing services and grant administration.
- This assistance helps businesses improve their operations, access new markets, and overcome challenges in the food supply chain.
- The Center also provides support for food value and supply chain coordination, fostering collaboration and efficiency among different businesses in the food system.




#### **Business Builder Sub-Awards**

- Once a year open application period
- Maximum awards \$50,000 (No match), 2-year implementation period
- Review committee comprised of 5 individuals from each State
- Eligible applicants: small to mid-sized value chain businesses (producers/growers, aggregators, distributors, processors, and food access points)
- Eligible uses: staff time, business planning activities (market analysis, feasibilities, ElA's) software implementation, equipment, marketing, and more.
- Priority is given to:
  - Applicants within or serving priority distressed zip codes
  - Minority or underserved applicants (Veterans, women, BIPOC, disabled, low-income, other)
  - Groups or consortiums of small to mid-sized value-chain businesses
  - Those that are receiving or have received Technical Assistance from TA providers
  - Those seeking to expand markets to institutions
  - Those meeting a specific market bottleneck or meeting ACTION PLAN goals
  - Equitable geographic distribution across each State.



#### 2024 Business Builder Sub-Awards Awardees



- Just over \$600,000 announced, evenly distributed across North Dakota, South Dakota, and Minnesota
- In all, 15 existing businesses, 5 in each of the three states, were awarded funding.
- 7 of the 15 awards are directed at businesses operating or substantially serving distressed communities in the region.
- 20% to new businesses.
- 53% to purchasing special equipment (food safety, processing, storage, packaging).







#### USDA Rural Energy for America Program

- LARC received \$250,000 in technical assistance grants to help with energy audits, technology assessments, and grant writing
- Renewable Energy Systems and/or Energy Efficiency Improvements
- Inflation Reduction Act allows up to 50% cost share if criteria met:
  - Zero GHG emissions at project level
  - Located in "Energy Community"
  - Energy efficiency improvements
  - Tribal entities



### Latino Economic Development Center

#### **Latinx Farmers Market in Minneapolis:**

- Partnered with the City of Minneapolis and the Minnesota Farmers Market
   Association; LEDC to host the first ever Latinx market showcasing diverse small
   businesses and food vendors to the Minneapolis community.
- Guaranteed our farmers payment through the Sanneh Foundation, funding \$15,000 for farmers' produce that will then be donated and distributed to the community for free, and taking any leftover produce to provide to refugee communities.
- Advocating for Latinx/BIPOC small businesses owners to become strong and impactful competitors in the market by provide hands on technical assistance and training.



#### **Latino Economic Development Center**

#### **LEAFF Program:**

- The LEAFF program through the Good Acre, was developed to help small scale emerging farmers survive the loss of their typical markets due to the pandemic; now serves as a state funded farm to food shelf program, providing technical support and local emergency assistance funding for farmers.
- This program guarantees our farmers a set dollar amount of produce and support by the program, that also provides cultural relevant food systems for local communities.
- With our farmers through the program, we have been able to serve and support underserved farmers and provide compensation with market prices for over 100 different crops.

#### **Emerging Farmers Conference:**

• Serves as an innovative conference that primarily serves the needs and provides resources for underserved emerging farmers (BIPOC, LGBTQIA+, Disabled, Veteran, Women farmers) to support building local economic development and building new networks of farmers, advocates, educators, and government officials.
